It's Back to School Time...

It is that time of the year when the kids get ready to enter (or return to) college...their venture away from home into a new and wondrous world.

We have all heard the stories about cousins attending the same schools without realizing their mutual presence. Dianne Linder, wife of **David R. Berman** (Chonon Berman/Chana Esther/Morris Berman/Samuel Berman) and mother of **Ilan Rafi Berman** (b. 2002) and **Aaron Matan Berman** (b. 2004) is the author of the recently published book, ***Beyond Words, Reflections on Our Journey to Inclusion***.

Diane writes:

*“I am a teacher and a parent of a child on the autistic spectrum. Even as a successful teacher for 18 years, I had a very difficult time finding an educational setting for him which was growth promoting. In the end my family had to relocate to a suburb of NYC in order to find what he needed. Once we moved, I saw such immediate growth that I realized I had a responsibility to understand the journey and to share with others in similar situations. The result was a book called **“Beyond Words, Reflections on Our Journey to Inclusion”** about my experiences navigating the world of special education from the dual perspective of parent and teacher. As the school year comes to a close, I am more eager than ever about spreading the message far and wide.*

“My son just completed 2nd grade and as his general education teacher handed me folders full of his work, she looked at me and said ‘Mrs. Linder, look all of this over carefully, it is time for you to raise your expectations for your son.’ She thanked me for ‘sharing him,’ and added that he is ‘delicious.’ He ended the year completing all of the work expected from any second grader. Considering he still tests in the ‘borderline’ IQ range, this is a strong statement in favor of inclusion. Considering two years ago, he ‘failed to function’ in two self contained kindergarten placements this is nearly miraculous.”

The book has been widely acclaimed. Typical of the responses are this of Ellen Waldman, PhD., Clinical Psychologist:

“This is a remarkable, touching and beautifully written story of a mother’s journey to help her son communicate, to enjoy life around him and to thrive in a world that challenges him every day. GENEALOGY UPDATES

1. We are endeavoring to establish the relationship between **Chonon Berman** and **Fannie Kravitz**. There has been a question raised as to whether they were brother and sister or, perhaps, cousins. While the family believes that they were siblings, they apparently had different fathers. We have ascertained that Fannie and her son Abraham came to this country from Smorgon, Russia, now Smorgon, Belarus, a town not far from Dolginovo where Chonon's family was originally from.

This particular research is being conducted for purposes of determining if there are siblings of Chonon and, if so, what happened to them, i.e. were they victims of the Holocaust, did they emigrate from Russia to the United States or elsewhere or, perhaps there are survivors still living in Russia or Belarus.

2. Whatever the relationship between Chonon and Fannie, we continue to clarify Fannie's genealogy and track her descendents. While we remain convinced that the **Michael Burack** family is genealogically related, research continues to fill in the existing gaps.

Addressing the questions relating to the relationship between Chonon and Fannie, Ted Gostin, the Genealogical Researcher from Sherman Oaks, CA who has been engaged in doing our Berman family genealogy, has preliminarily reported:

“Both the stories that Michael BURACK said he heard about Fannie from his mother, and the things I have found, suggest that Fannie’s husband died before Fannie and her son Abraham came to the United States. As for having friends or family here before she came ...we have no information on who this may have been. All of your grandfather Honon BERMAN’s family arrived after Fannie did, not before.”

We are embarked on continuing research to determine the relationship between Chonon and Fannie and the existence of (other) siblings of Chonon as a basis to undertake the goal set forth in (3).

3. One of the defined goals of our genealogical quest is to determine if any of our family members were victims of the Holocaust.

While we do not presently know if they have any connection to our own Berman family, we have identified the following “Berman” Holocaust victims from Dolginovo:

* Yehoshua or Shaya BERMAN, born 1898, son of Elye BERMAN, occupation hairdresser, died May 1942 in Dolginovo, age 45.

* Khasia or Hasia (Katz) BERMAN, wife of Yehoshua/Shaya, daughter of Girsh KATZ, born 1899, died May 1942 in Dolginovo, age 45.

* Zelig or Zelik BERMAN, son of Yehoshua/Shaya & Khasia (Katz) BERMAN, born 1922, died May 1942 in Dolginovo, age 19.

* Rivka or Riva BERMAN, daughter of Yeshoshua/Shays & Khasia (Katz) Berman, born 1925, died May 1942 in Dolginovo, age 17.

The research continues.

4. Eugene B. Berman, Sr. (me, the “subject”), as an expansion of his research, has undergone genetic (DNA) testing with DNA Consulting of Sante Fe, NM. A portion of the Report stated:

“To explore geographic origins of the subject’s type in history, we compared 11 of these sources, representing the subject’s haplotype with the forensic gene bank known as the Y Chromosome Haplotype Reference Database (YHRD) in Berlin. A single match was found in a world sample of 52,655 haplotype in 464 populations.

“The male in Poland and the subject are genetic cousins descended from the same forebear as the subject within about the past approximately 3,000 years (Heyer et al, 1997). The haplogroup is R1b. In Ysearch there was an exact match on an extended basis to a descendant of Yacov Epstein ha Levi, born about 1820 in Slonim, Belarus (DJF3C: contact sorlen@email.arizona.du). This descendant and the subject are very likely cousins in a genealogical, as well as a genetic, sense.”

In the surprising turn of events that is common to genealogical research, it turns out that Steve Orlen’s (sorlen) family was from Holyoke, MA where Eugene was born and raised. The families knew one another. The fact is that one of the Epstein families (“Haberman”) was Eugene’s best friend. Ah, the excitement of discovery in the world of genealogy! The DNA match means that all of the Berman family is related to the Epstein family through the common ancestor, Yacov Epstein ha Levi.

*As we continue the process of building the family tree and retrieving the family history, we would welcome members of the family sharing such knowledge that they may have that has been passed down from one generation to the next. Take the time to write those special remembrances of earlier generations and forward them to be preserved in **This Is Us** (the Berman family history) and shared with members of the family.*

Copies of old photographs are most welcomed...if accompanied with identification of the individuals, date and place...as known.

Copies of documents, pictures of gravestones and other historic artifacts are also solicited to be added to "the Berman collection."

While everyone may not be a genealogy or history buff, the interest in things Berman is great and it is surprising to see the number of the young people who use the accumulated information for their own further research or as the basis for school essays or family history papers.
