# 100 YEARS....a Century

February 16, 2012 marks the 100<sup>th</sup> Anniversary of the date that **Chonon Berman** (b. 1852-1936) a citizen of the United States of America (Petition for Naturalization No. 636)....a century of citizenship for the Berman family!

Two of his sons, **Hyman** (1882-1936) and **Benjamin** (1885-1964) became citizens at the same event before the United States District Court for the State of Connecticut in New Haven, CT and **Harry** (1897-1974), a minor at the time, obtained derivative citizenship through the naturalization of his father, Chonon.

Chonon, a peddler by occupation at the time of his naturalization, was born in Dolginow, Russia on or April 3, 1852, departed from Liverpool, England aboard the vessel Cornia on or about June 12, 1906 and arrived at the Port of New York on June 20, 1906.

We are pleased to announce that **Judith Berman Levine** (b.1933)(Chonon Berman/Harry Berman) has recovered from her recent surgery with a good prognosis.

Judy has provided the Berman Family Archives with the original July 28, 1906 Certification of the intention of Honon Berman "that it was *bona fide* his intention to become a CITIZEN OF THE UNITED STATES, and to renounce forever all allegiance and fidelity to every foreign Prince, Potentate, State and Sovereignty, whatsoever – and particularly to Nicholas, Emperor of Russia."

Also included in the cache of materials provided are original copies of "*The Berman Announcer*", Vol. 1, No. 8 dated March 1951 and Vol. 2, No. 4 dated October, 1955.

The **Announcers** are fascinating in their revelation of tidbits of the family history.

The March, 1951 issue announced the April 21at Seder to be held at Beth Hamedrosh Hagodol at George & Dwight Streets in New Haven at a cost of "only \$6.00 per adult" with "every unmarried child will attend the Seder at no cost to his parents." Herman Russion was to be the Master of Ceremonies with Elders David Russion and Meyer Berman scheduled to officiate at the Seder Services.

(**Editor's Note**: I remember the 1951 Seder well. It was the first Seder that I attended after being admitted to the bar, being discharged from the Army and having married.)

The October, 1955 issue, a carbon copy typed on onion skin paper, announced a Berman Family Meeting to be held in the Vestry of Beth Hamedrosh Hagodol. Arnold Berman was President, Sidney Rhein Vice-President, Benjamin Berman Treasurer, Celia Beyer Corresponding Secretary and Bess Doff Recording Secretary. The notice of the meeting sets the tone:

"Everyone is looking forward to this meeting, not because of any earth-shattering Matters to be resolved, but to be together as a Family and enjoy being with one another. Family matters, of course, will receive the earnest consideration of all of us, for therein lies our strength and our unity."

We frequently refer to the Republic of Belarus as the country from which the Berman Family emigrated to come to the United States. The truth is that at the time of our family's emigration, the area from whence we came was, in fact, Russia...the then Russian Empire.

The Republic of Belarus, a land-locked country in Eastern Europe in the heart of the 19<sup>th</sup> century Pale of Settlement, became a country after the break-up of the Soviet Union in 1990. Most of the territory of present-day Belarus was in Poland on 1920 and in the USSR during World War II and during the post-war period until 1990.
